**Subject: Mandatory Submission of APAAR ID for Credit Data Upload on ABC Portal**

As per the UGC notice No. DO No. F.1-50/2021(ABC/NAD) dated 07-08-2024, it is mandatory for all universities in India including IIPS to upload the ABC ID-mapped credit data related to the courses run during the academic years 2021, 2022, and 2023.

In compliance with this notice, the academic section has made several efforts to inform the pass-out students of MPS/MA-M.Sc/MBD programmes for the period mentioned above through emails, personal calls, WhatsApp messages etc., However, it has come to notice that many students have not yet created their APAAR accounts on the ABC portal of DigiLocker.

It is therefore, concerned students may note that the uploading of credit data for all courses is a one-time process. Due to the non-availability of APAAR accounts for several students, the Institute is unable to upload the credit data for all PG programme for the period mentioned above.

In view of this, all students are one again advised to take this notification seriously and comply with UGC's requirement promptly and ensure that he/she has submitted their APAAR ID details to the Academic Section on or before 30.11.2024.

**Those students who fails to to submit the APAAR ID by 30.11.2024 will result in the non-declaration of his/her credit data on the ABC portal. No further requests regarding this matter will be considered after the deadline and Institute will not be responsible in this regards.**
